#### Access:

## Attendance:

- Establish a structured remote learning schedule with clear start and end times for classes.
- Expect regular attendance and active participation from students during remote sessions.

# **Curriculum:**

- Deliver curriculum content through digital platforms, pre-recorded lessons, live video sessions, and interactive activities.
- Ensure alignment with curriculum standards and learning objectives.

## Assessment and feedback:
